AIS (ASAHI INDIA GLASS LTD.) ANNOUNCES UNAUDITED FINANCIAL RESULTS FOR THE THIRD QUARTER AND THE NINE MONTHS ENDED  $31^{\rm st}$  december, 2009

New Delhi, 21<sup>st</sup> January, 2010 - AIS (Asahi India Glass Ltd.), India's largest integrated glass Company announced its unaudited financial results for the third quarter and the nine months ended 31<sup>st</sup> December, 2009 at its Board Meeting held today.

The consolidated financial performance highlights for the third quarter ended 31<sup>st</sup> December, 2009 are as follows -

- Net sales at Rs. 32,369 lakhs, increased by 14.07% over the corresponding quarter of the previous year (Rs. 28,377 lakhs)
- Earnings before Interest, Depreciation and Taxes (EBIDTA) at Rs. 6,637 lakhs doubled (increase of 114.58%) over the corresponding period of the previous year.
- Cash profit has turned positive to Rs. 3,502 lakhs as against a negative of Rs. 445 lakhs in the previous period.
- Profit After Tax (PAT) at Rs. 117 lakhs has also turned positive as against a loss of Rs. (2,220) lakhs in the previous period.

Speaking on the occasion, Mr. Sanjay Labroo, MD & C.E.O., AIS said -

"After a gap, AIS has made a profit this quarter. Though marginal, this profit reflects the slow-but-sure return of AIS to its past performances. Although, most of the improvement in the financial performance has been due to the very strong performance in the automotive segment, we are now confident of better business conditions in the architectural segment also.

However, with the new capacities coming up, the competition in the float glass segment is increasing, resulting in weakening of prices of basic varieties of float glass. The key differentiator, therefore, would be to have a correct product mix with increased offerings of high quality valued-added products. AIS continues to compete in this segment by offering series of new value-added products, which have been well received in the market.

Overall, I think we are in line with our projected recovery path and expect to do much better than last year. "
