Dear Sir,

I, Sanjeev Pandey, Partner, M/s. SSPK & CO., a Company Secretaries firm having its office at 308, S.G Shopping Mall, D C Chowk, Rohini, Delhi 110085, have been appointed as the Scrutinizer by the Asahi India Glass Limited ("Company") for the purpose of conducting the Postal Ballot / Remote E-Voting process carried out by the Company as per provision of Section 110 of the Companies Act, 2013 and Rule 22 of Companies (Management and Administration) Rules 2014 including any statutory modification or re-enactment thereof for the time being in force, and SEBI (Listing Obligation and disclosures Requirements) Regulation, 2015 (Listing Regulations) on resolutions as mentioned in the Notice of Postal Ballot dated 17<sup>th</sup> February, 2023 in a fair and transparent manner and do hereby submit my report as under:

- The dispatch of Postal Ballot Notice along with the postal ballot form was completed on Wednesday, 22<sup>nd</sup> February, 2023.
- 2. The Company had appointed Central Depository Services Limited (CDSL) for facilitating e-voting services to enable the Members to cast their votes electronically. The e-voting





commenced on Sunday, 26<sup>th</sup> February, 2023 (09:00 A.M.) and ended on Monday, March 27, 2023 (05:00 P.M.). The Voting facility was blocked forthwith thereafter.

- The last date for receipt of postal ballot forms was Monday, 27<sup>th</sup> March, 2023 (05:00 P.M.).
- 4. The Company had duly published an advertisement on 23<sup>rd</sup> February, 2023 in Business Standard", all editions & "Veer Arjun", newspaper & regarding completion of dispatch of Notice of Postal Ballot dated 17<sup>th</sup> February, 2023 and also specifying therein the matters prescribed in the Rules with regard to e-voting.
